(57) **CLAIM**

The ornamental design for a separator for fuel cell, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the top, front, and left side of a separator for fuel cell showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a right side view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom view thereof;

FIG. 8 is a partially enlarged view of the upper end portion of the left side view thereof;

FIG. 9 is a partially enlarged view of the lower end portion of the left side view thereof;

FIG. 10 is a partially enlarged view of upper left end portion of the front view thereof;

FIG. 11 is a partially enlarged view of the lower left end portion of the front view thereof;

FIG. 12 is a partially enlarged view of the left end portion of the top plan view thereof; and,

FIG. 13 is a partially enlarged view of the left end portion of the bottom view thereof.
