**DESCRIPTION**

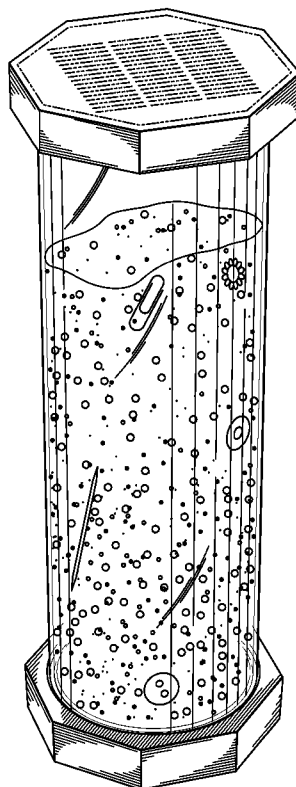
FIG. 1 is a perspective view of a bottle game showing my new design;

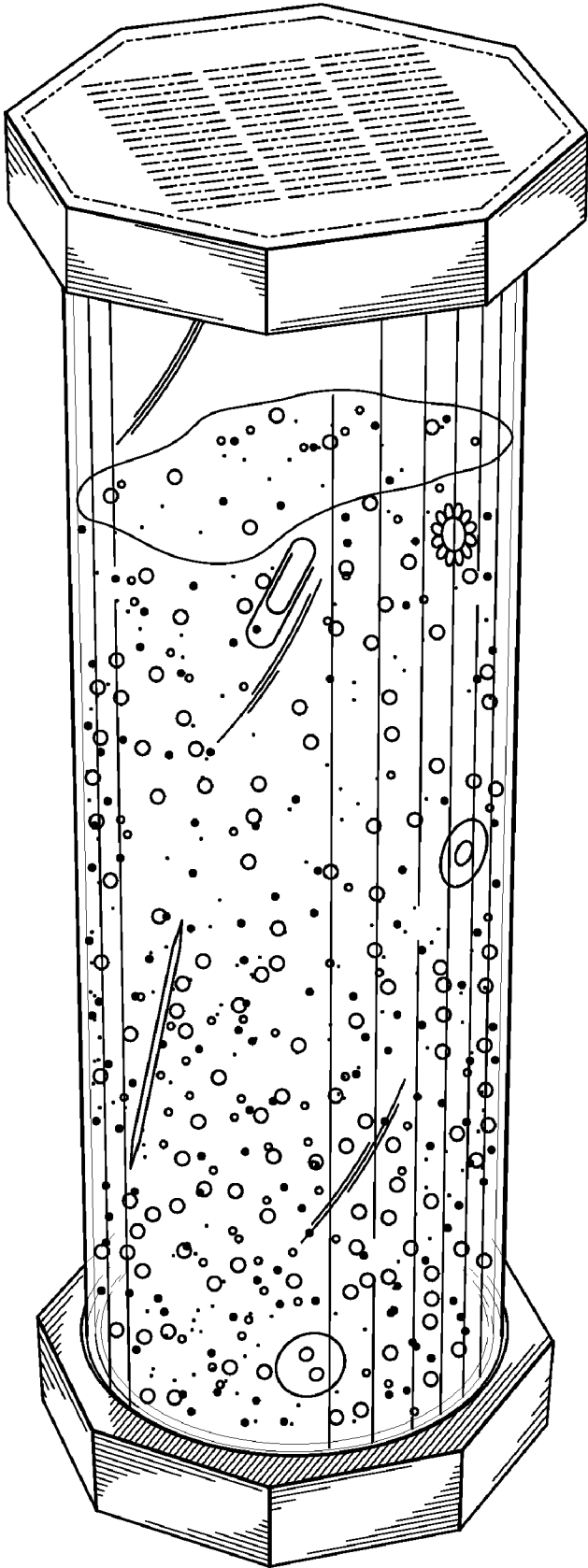
FIG. 2 is a side view of the bottle game shown in FIG. 1;

FIG. 3 is a top view of the bottle game shown in FIG. 1; and, FIG. 4 is a bottom view of the bottle game shown in FIG. 1.

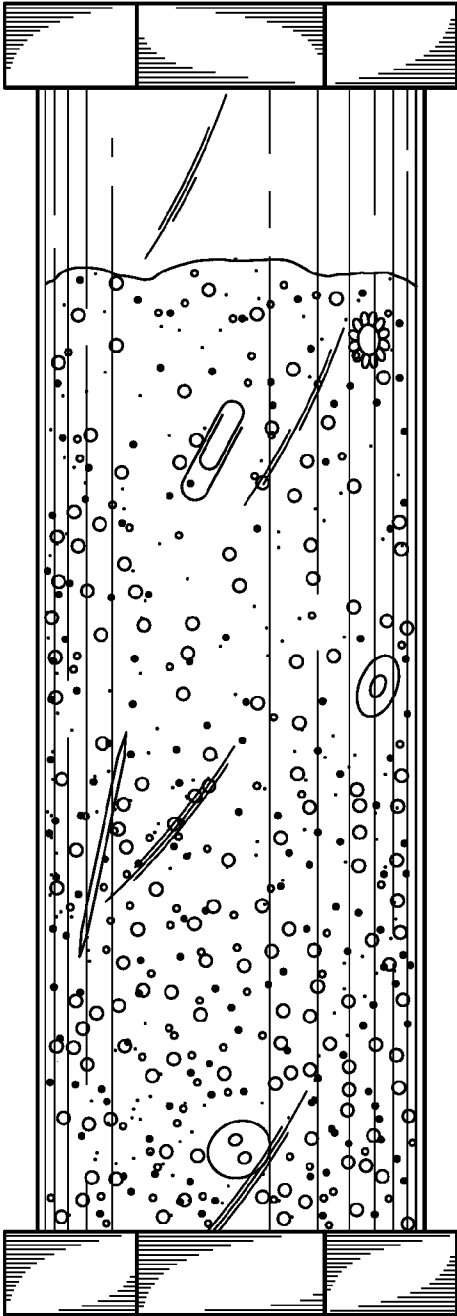

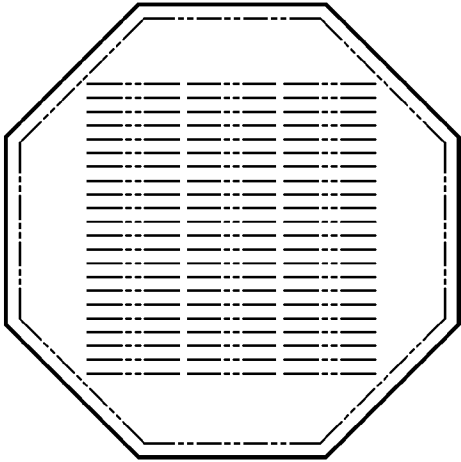




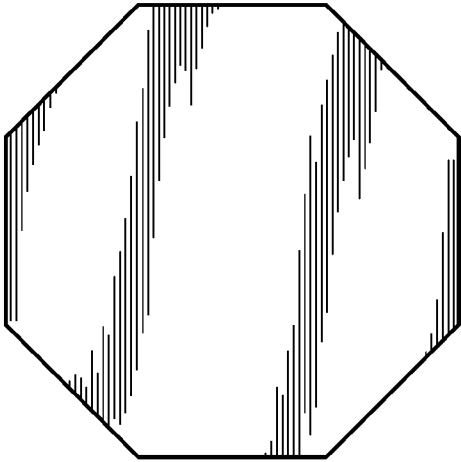
